Background:

Apex Wake Park, Inc. (Apex) currently leases a portion of the lake located at the NMB Park and Sports Complex. Regarding the rental amount Apex pays to the city, the lease provides as follows:

For each calendar year of the lease beginning with January 1, 2017 and continuing through the Lease Termination Date, the Lessee shall pay rent to the City equal to the greater of (i) minimum rent of Twenty Thousand and 00/100 (\$20,000.00) (“Minimum Rent”); or the percentage of gross revenue generated from the Leased Premises as set forth below:

Less than \$1,000,000	7% of Gross Revenue to the City
More than \$1,000,000+	10% of Gross Revenue to the City
More than \$1,300,000+	12% of Gross Revenue to the City
More than \$1,600,000+	14% of Gross Revenue to the City
More than \$2,000,000+	15% of Gross Revenue to the City

Apex has requested the lease be amended to eliminate the table above so that the lease provides for a rental rate equal to the greater of (i) minimum rent of Twenty Thousand and 00/100 (\$20,000.00) **or** 8% of Gross Revenue generated from the leased premises.

The Director of Parks and Recreation supports the proposed change to the rental rate.

AN ORDINANCE

AN ORDINANCE OF THE CITY OF NORTH MYRTLE BEACH TO AMEND THE LEASE AGREEMENT BETWEEN THE CITY AND APEX WAKE PARKS, INC., SECTION 5, TITLED RENTAL, TO PROVIDE THAT THE LESSEE SHALL PAY TO THE CITY ANNUALLY THE GREATER OF THE MINIMUM RENT OF \$20,000.00 OR 8% OF THE GROSS REVENUE GENERATED FROM THE LEASED PREMISES.

WHEREAS, the City and Apex Wake Park, Inc. (Apex) entered into a lease dated September 24, 2015, which stipulated Apex would pay rent to the City equal to the greater of (i) minimum rent of Twenty Thousand and 00/100 (\$20,000.00) Dollars or (ii) the percentage of Gross Revenue generated from the Leased Premises as set forth below:

Less than \$1,000,000	7% of Gross Revenue to the City
More than \$1,000,000	10% of Gross Revenue to the City
More than \$1,300,000	12% of Gross Revenue to the City
More than \$1,600,000	14% of Gross Revenue to the City
More than \$2,000,000	15% of Gross Revenue to the City

WHEREAS, Apex has requested that the lease be amended to include annual rent to the City equal to the greater of (i) minimum rent of Twenty Thousand and 00/100 (\$20,000.00) Dollars or (ii) Eight percent (8%) of Gross Revenue to the City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL FOR THE CITY OF NORTH MYRTLE BEACH, SOUTH CAROLINA:

Section I: An amendment to the Lease Agreement is authorized to set the annual rental to be paid by the Lessee to the City equal to the greater of the minimum rent of Twenty Thousand and 00/100 (\$20,000.00) or 8% of Gross Revenue generated from the leased premises.

Section II: The City Manager is authorized to sign the addendum to the Lease Agreement on behalf of the City.

Section III: The ordinance shall become effective upon the signatures of the City and Apex to the addendum to the Lease Agreement.
