Background:

Meritage Homes of the Carolinas incorrectly recorded a Deed of Dedication. The City should reconvey to Meritage Homes of the Carolinas the streets identified as Copper Creek Loop and Dunes Points Way (and the drainage systems associated with these streets) which were incorrectly conveyed to the City as public streets.

The above referenced streets were accepted by the North Myrtle Beach Planning Commission as *private streets* and the recorded plat for this area indicates the streets *are private*.

To correct this issue, the City will convey the above referenced streets back to Meritage Homes by quitclaim deed (attached for Council's review).

AN ORDINANCE

AN ORDINANCE OF THE CITY OF NORTH MYRTLE BEACH TO RECONVEY TO MERITAGE HOMES OF THE CAROLINAS THE STREETS IDENTIFIED AS COPPER CREEK LOOP AND DUNES POINT WAY (AND THE DRAINAGE SYSTEMS ASSOCIATED WITH THESE STREETS) WHICH WERE INCORRECTLY CONVEYED TO THE CITY BY DEED OF DEDICATION AS PUBLIC STREETS

WHEREAS, Meritage Homes of the Carolinas was involved in the development of the Waterside neighborhood; and

WHEREAS, the streets identified as Copper Creek Loop and Dunes Point Way were presented to the North Myrtle Beach Planning Commission as private streets; and

WHEREAS, the North Myrtle Beach Planning Commission accepted the above referenced streets as private streets; and

WHEREAS, a plat was recorded which depicts the above referenced streets as private streets; and

WHEREAS, Meritage Homes incorrectly filed a deed of dedication regarding the above referenced streets as public streets; and

WHEREAS, to correct the record regarding the status of the streets, it is necessary for the City to convey back to Meritage Homes the above referenced streets as private streets.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL FOR THE CITY OF NORTH MYRTLE BEACH:

SECTION 1: The quitclaim deed to convey the above referenced streets to Meritage Homes of the Carolinas, Inc. is hereby approved.

SECTION 2: The Acting/Interim City Manager is authorized to sign the quitclaim deed and other documents that may be necessary to complete the transaction.

SECTION 3: The ordinance shall be effective upon the date of passage.
