Background:

The proposed ordinance modifies code Sections 11-1 and 11-1.1 of Chapter 11 of the North Myrtle Beach Code of Ordinances titled Fire Prevention as follows (edits in red):

11-1. International Fire Code adopted.

Pursuant to Title 6, Section 6-9-50A of the 1976 South Carolina Code of Laws as amended, is hereby adopted by reference, for the purpose of establishing rules and regulations for life safety, fire prevention and maintenance of buildings, structures and premises, the following code is hereby adopted and incorporated as fully as set at length herein.

The International Fire Code, in its most current edition, as adopted by the South Carolina Building Code Council.

The International Fire Code shall control within the city; however, that in the event any conflict that may arise between the provisions of the International Fire Code and this Code of Ordinances or state law, the provisions of state law or this code of Ordinances shall prevail and be controlling as provided in section 1-6.

11-1.1. Chapter One of the International Fire Code adopted.

The Chapter entitled “Administration” of the most current edition of the International Fire Code, as adopted by the South Carolina Building Code Council, is hereby adopted.
